

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.sacredvesselacupuncture.com, and Sacred Vessel Acupuncture LLC. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Sacred Vessel Acupuncture LLC. include www.sacredvesselacupuncture.com and Sacred Vessel. The Sacred Vessel website is a service business, and educational site. By using the Sacred Vessel website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Sacred Vessel may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address

If you purchase Sacred Vessel's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Sacred Vessel may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Sacred Vessel's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Sacred Vessel collects and uses your personal information to operate and deliver the services you have requested.

Sacred Vessel may also use your personally identifiable information to inform you of other

products or services available from Sacred Vessel and its affiliates.

Sharing Information with Third Parties

Sacred Vessel does not sell, rent or lease its customer lists to third parties.

Sacred Vessel may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. Sacred Vessel may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Sacred Vessel, and they are required to maintain the confidentiality of your information.

Tracking User Behavior

Sacred Vessel may keep track of the websites and pages our users visit within Sacred Vessel, in order to determine what Sacred Vessel services are the most popular. Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Sacred Vessel. Use of Cookies

- public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
